



Nunn Beach Open for Swimming (Effective weekends starting June 26, 2020)

Hours of Operation:

Friday – Sunday 1200 Noon to 6:00 PM Weather and Water Quality Permitting

- 1. Currently open to All Hands**
- 2. Nunn Beach Capacity – 175 Patrons (swimming and/or the beach)** in order to maintain 6 feet social distancing. Staff will be on hand to regulate and enforce these numbers accordingly.
- 3. Access points: Entry, South side of Beach house. Exit, North side of beach house near outdoor shower area.**
4. Outdoor Beach House Patio Capacity – 20 Patrons (Maintain 6ft. Social Distancing, Face Masks Required)
- 5. Swimming and Wading are not permitted outside of Normal Operational Hours or when Lifeguard Staff are not on duty. Base security will enforce these policies.**

Currently Allowed:

- 1) Sunbathing – with appropriate social distancing
- 2) Swimming/Wading – With lifeguards on duty during normal operational hours
- 3) Exercising – with appropriate social distancing
- 4) Individual Sports (Throwing Footballs, Frisbee’s etc.) with appropriate social distancing
- 5) Chairs & Umbrella’s, Canopies and Coolers (Alcohol not permitted at Nunn Beach)
- 6) Volleyball – Please limit to no more than 10 people

Currently Not Allowed:

- 1) **Water Sports: Including kayaking, canoeing and stand up paddle boards.**
- 2) **Alcohol/Smoking including the use of E-cigarettes and vaping is prohibited at all times.**
- 3) **Fishing: Please see the MWR Marina for questions about fishing.**
- 4) **Large Groups: Please see the MWR Community Recreation for rentals of the Beach House**
- 5) **Group/Organized Sports: not authorized to help us keep our Beach capacity numbers fair.**
- 6) **Loud/Offensive Music (Music must be kept family friendly)**

Health and Safety Considerations:

- 1) Please do not come to the beach if you, or someone you live with, is sick
- 2) Please dispose of all trash accordingly and clean up after yourself
- 3) Glass Bottles are not permitted at any time**
- 4) Alcohol is not permitted to be poured into any additional container in an attempt to hide it**
- 5) Patrons must remain within the designated swim and beach zones (Signs will be posted to designate zones)
- 6) Face Coverings, when out of the water, are not required but recommended if you cannot maintain at least 6 feet of social distancing. Family members of the same household are not required to social distance.**
- 7) MWR Staff will work to ensure compliance with these guidelines. Violators may be asked to leave.
