

Fishing is permitted from the front of the pier to the elbow and only in the areas designated by the safety cable on the north (left) side of the pier.

NO FISHING ON THE SOUTH (RIGHT) SIDE OF THE PIER OR PAST THE BEND.

PIER FISHING RULES

- ALL VIRGINIA STATE AND FEDERAL FISHING REGULATIONS MUST BE OBSERVED.
- 2. Only authorized personnel listed below may fish from the pier.
 - a. Active duty, retirees, Reservists and eligible family members.
 - b. DoD personnel (current and retired)
 - c. Guests of the above
- 3. Authorized persons must possess a current CAX Pier Pass. The permit allows the holder up to TWO ADULT guests (or immediate family members) to fish from the pier. There must be two adults on the pier to fish.

- 4. Fishing hours: Monday to Friday from 4 p.m. to 6 a.m. and 24 hours on Saturday and Sunday. The pier may be closed at any given time, without notice, or operations or weather conditions. No fishing when a ship is docked.
- Driving on the pier is prohibited. Security staff may authorize exceptions for severely handicapped or disabled persons. The pier parking lot is located at the intersection of Sanda Avenue and Point Road.
- 6. Adults are responsible for their children. Children 16 and younger are required to wear a life jacket.
- 7. Children WILL NOT be left unattended in vehicles. Baby carriages, play pens, etc. are not permitted on the pier.

- 8. If someone falls off the pier, shout "MAN OVERBOARD" until assistance arrives. Obtain a life ring from the nearest hanger on the safety rail and pull the nearest fire alarm box. Boxes are located at the elbow of the pier, midway between the elbow and the telephone pole at the end of the pier.
- 9. LITTERING is absolutely prohibited (including fishing line) and can be cause for permanent revocation of pier pass.
- 10. Consumption or possession of alcoholic beverages is absolutely prohibited.Violation of this or any other regulation can result in a loss of fishing privileges.
- 11. Absolutely no smoking on the pier.

FRESHWATER FISHING RULES

- Base permits must be obtained for freshwater fishing for everyone between the ages of 16 - 65.
- Must have a valid Virginia Freshwater fishing license in addition to the base permit.
- 3. Freshwater base permits expire every year on December 31.
- 4. An MWR weekly or annual freshwater pass is required.
